Basis for foundation

- Despite being a mature oil province, NCS still has significant remaining potential, both within current producing fields, undeveloped discoveries and exploration
- Due to the remaining potential, framework changes and high oil prices the number of players on NCS has increased from ~15 in 2000 to ~60+ in 2011, and the exploration activity on NCS is today at all time high
- Going forward the number of asset transactions on NCS will increase. Numerous exploration farm-outs will be made. Several discoveries will be made by E&P minors of which several will be sold before development. Some major E&P companies will also sell mature producing assets.
